## **GIVING FUND GRANT RECOMMENDATION GUIDELINES**

**Charitable Organizations:** The Giving Fund may make grants only to organizations that are exempt under Internal Revenue Code ("IRC") Section 501(c)(3) and that are classified as public charities under IRC Section 509(a)(1) and applicable regulations and IRS authority.

**Grant Minimum:** Each grant must be a minimum of \$250 and specified in \$50 increments.

**Fees:** There is no charge for processing grant recommendations.

**Grant Recommendation Limitations:** Grant recommendations to non-Southern Baptist charities are subject to review and approval by the Directors of the Baptist Foundation of Oklahoma ("Directors"). All grants must comply with the Giving Fund Policy. Recommended grant recipients must be recognized by the Internal Revenue Service as an organization exempt from tax under Section 501(c)(3) of the Internal Revenue Code and as a public charity under section 509(a)(1) of the Internal Revenue Code. Grants must be used exclusively in furtherance of charitable purposes and the donor, donor advisor or third party cannot receive goods, services or any form of impermissible private benefit from the proposed grant. Grants from the Giving Fund may not be used for any pre-existing pledge\* or private benefit (such as school tuition or scholarships sent directly to individuals, dues, membership fees, admission to charitable events or goods bought at charitable auctions). Nor may grants be used for lobbying, political contributions or to support political campaign activities. Any grant recommendation received for any improper purpose will be rejected.

\*Note: A pledge is a verbal or written promise to make a gift to charity. Typically, the amount of the gift is specified at the time the pledge is made. "Pre-existing" means the pledge was made prior to the submission of the grant recommendation to the Giving Fund. If you would like to respond to a solicitation from a charity, you may want to inform the charity you will make a recommendation to the Directors to consider a grant to the organization. For example, you could say, "It is my intention to make a recommendation(s) that The Baptist Foundation of Oklahoma Giving Fund support your organization at its legal address."

**Tax Treatment of Gift Fund Grants:** When the Giving Fund redeems units from the Giving Fund Account to make grants, the Giving Fund is granting its own assets. Accordingly, you are not eligible for additional charitable deductions for these grants. (Your charitable contribution deduction was available at the time of the contribution to the Giving Fund).

## **Grant Check Processes:**

- The Giving Fund will not forward any enclosures with grants.
- The Giving Fund must make grant checks payable to the recipient organization's legal name, which may be different from the common use name. Grants will be disbursed directly to the recipient organization at their legal address. Donors may not serve as intermediaries.
- Your grant recommendation is non-binding and is subject to review and approval by the Directors. Please allow up to ten business days for review, approval and processing of the grant.
- You may request that grants be issued on a future date (e.g., December 20, 20XX) or at recurring intervals (e.g., monthly, quarterly, semi-annually).
- Confirmation that the grant was approved and sent will be mailed to the primary donor once the grant has been issued.

**Special Purpose:** Each grant may have a special purpose, such as operating expenses, a particular fundraising campaign, to honor a loved one, etc. If the purpose of your grant is to honor a loved one and you wish to notify the family of the honoree, please include the name and address of the family on the special purpose line.
